- THE DRIVER SAFETY PROGRAM: Your class assignment form will be emailed or mailed to you in 4-6 weeks. SOME CLASS SITES HAVE LIMITED OR RESTRICTED SCHEDULES. Your request will be honored, if there is availability. If not, then next closet site will be scheduled. If you are unable to attend your scheduled class IMMEDIATELY CALL THE DRIVER SAFETY PROGRAM OFFICE AND RESCHEDULE. (You may reschedule one time at no charge with Shawnee College Only). Call no later than the date stamped on your class assignment form. **If you miss your class you must reschedule for another class and pay \$10 fee.** REMEMBER: Traffic Safety School must be completed before the court supervision completion date which will be 150 days from THE DATE OF PLEA AND PAYMENT.

**\* OUT OF AREA MOTORISTS**

If you are eligible to attend a Defensive Driving Course (4 credit hours) in your area and have met eligibility requirements you will still need to enroll in our program for tracking purposes.
